Dear Ms. Jankowicz:

We have made several requests to you for documents and information relating to the socalled "Disinformation Governance Board" within the Department of Homeland Security and your role as the Board's Executive Director. These requests, to include your appearance for a transcribed interview before the Committee, remain outstanding. These documents and your testimony are necessary to further our oversight. As we begin the 118th Congress, we write again to reiterate our outstanding requests and ask that you immediately comply in full.

You have been on notice about our oversight requests—and are aware that the requests are outstanding—for months. For your convenience, we have attached the letters dated May 5, 2022, and December 1, 2022.<sup>1</sup> Although your attorney has belatedly contacted the Committee, our requests are still outstanding. Accordingly, we reiterate our requests and ask that you comply promptly. The Committee is prepared to resort to compulsory process, if necessary, to obtain your testimony and this material.

The Committee on the Judiciary is authorized to conduct oversight of matters involving civil liberties, including free speech and the First Amendment, pursuant to the Rules of the House of Representatives.<sup>2</sup>

Dear Ms. Jankowicz:

On April 27, 2022, Homeland Security Secretary Alejandro Mayorkas testified that the Biden Administration had established a so-called "Disinformation Governance Board" to combat alleged disinformation and misinformation.<sup>1</sup> According to news reports, which you acknowledged on Twitter, you will lead the board as its executive director.<sup>2</sup> This Board is un-American, anti-democratic, and a dangerous escalation of the Biden Administration's embrace of government-endorsed censorship. In addition, judging from your past statements, Americans can not and should not trust you with your newfound authority to act as the Biden Administration's arbiter of the truth.

The Biden Administration has shown that it has, at best, a tenuous relationship with the truth. For example, President Biden has repeatedly and falsely asserted that facts about Hunter Biden's business dealings with corrupt Ukrainian and Communist Party-linked Chinese nationals are Russian disinformation.<sup>3</sup> President Biden made these assertions despite an independent Senate investigation substantiating many of the allegations.<sup>4</sup> The *New York Post* has similarly reported on these dealings for years, and the *New York Times* and the *Washington Post* have more recently confirmed much of the original reporting.<sup>5</sup>

You have similarly propagated this and other misinformation.<sup>6</sup> On October 14, 2020, you were quoted in an *Associated Press* article about Hunter Biden's laptop as saying it "should [be] view[ed] as a Trump campaign product."<sup>7</sup> On October 22, 2020, you argued that the laptop story was "a [fairy] tale about a laptop repair shop."<sup>8</sup> On March 16, 2021, you asserted that an intelligence community assessment about Russian and other foreign activities related to the 2020 election was a "clear nod to the alleged Hunter laptop."<sup>9</sup> On April 2, 2021, despite your statements to the contrary, Hunter Biden conceded that the laptop may have been his, and the *New York Times* subsequently reported that he had abandoned the laptop at the Delaware repair shop.<sup>10</sup>

You have also pushed left-wing disinformation about the so-called "Steele Dossier," the false and tawdry set of allegations about President Trump generated and pushed by Democrat operatives during the 2016 election cycle. On April 22, 2020, you promoted the false narrative that the Steele Dossier "began as a Republican opposition research project."<sup>11</sup> In fact, it was "Hillary Clinton's campaign and the Democratic National Committee" that paid "Fusion GPS [beginning] in April [2016] for research that eventually became the basis for the dossier."<sup>12</sup> You later promoted an interview with Steele that you described as providing "some great historical context about the evolution of disinfo."<sup>13</sup> You also promoted other theories, for instance about disclosures made by then-Director of National Intelligence John Ratcliffe, that turned out to be false.<sup>14</sup>

The establishment of the Biden Administration's Board and your appointment to lead it gives rise to considerable concerns about its effect on Americans' fundamental civil liberties. The ability of Americans to engage in robust debate and conversation is the foundation of American politics, and there is no place for a *de facto* ministry of truth in our government. The very idea of a ministry of truth should be revolting to all Americans who hold our Bill of Rights in high regard.

- 3. What information and data do you intend to collect and from what sources?
- 4. What safeguards, if any, will you implement to ensure you respect the First Amendment rights of all Americans, not just those with whom you agree?
- 5. What specific actions will you take to counter what it views to be misinformation or disinformation, and what approval will be necessary before you take that action?

Dear Ms. Jankowicz:

On May 5, 2022, we wrote to you requesting documents and information relating to the so-called "Disinformation Governance Board" within the Department of Homeland Security (DHS) and your role as the Board's Executive Director.<sup>1</sup> You never responded to our letter, and the DHS's response did not alleviate our concerns. Since then, new information has come to light about the Biden Administration's embrace of government-driven censorship and its effort to "police disinformation."<sup>2</sup> Accordingly, we write to reiterate our outstanding requests.

As we explained in our letter of May 5, the "Disinformation Governance Board" was an anti-democratic and un-American attempt to establish a *de facto* Ministry of Truth within the federal government. This effort shows the Biden Administration's distrust of the American people and raises substantial concerns about the Administration's commitment to protecting fundamental civil liberties. The documents we requested in our letter, which is enclosed, are necessary for our oversight. To the extent you possess responsive documents in your personal possession, please produce this material as soon as possible but no later than December 15, 2022. If you possess no responsive material in your personal possession, please make a certification to the Committee to that effect.

Additionally, in our letter of May 5, we requested that you appear before the Committee to answer questions about the Board, its work, and your previous statements promoting false public narratives. This request, too, is outstanding. We therefore ask that you appear for a transcribed interview about the "Disinformation Governance Board" and related matters. Please contact Committee staff promptly to schedule your transcribed interview.
