# RESOLUTION

Of inquiry requesting the President to transmit to the House of Representatives certain documents relating to misinformation and the preservation of free speech.

1       *Resolved*, That the President of the United States is  
2 requested to transmit to the House of Representatives, not  
3 later than 14 days after the date of adoption of this reso-  
4 lution, copies of any document, record, audio recording,  
5 memorandum, call log, correspondence (electronic or oth-

1 erwise), or other communication in his possession, or any  
2 portion of any document, record, audio recording, memo-  
3 randum, call log, correspondence (electronic or otherwise),  
4 or other communication, that refers or relates to the com-  
5 munication or coordination between the personnel of the  
6 Executive Office of the President and the personnel of the  
7 Federal Communications Commission with respect to the  
8 following:

9           (1) Regulation of programming decisions by  
10       multichannel video programming distributors relat-  
11       ing to misinformation.

12           (2) Regulation of programming decisions by  
13       broadcast stations relating to misinformation.

14           (3) Regulation of programming decisions by  
15       providers of video streaming services and other over-  
16       the-top video programming distributors.

17           (4) Issuing any rule, regulation, policy, doc-  
18       trine, standard, or other requirement that has the  
19       purpose or effect of reinstating or repromulgating  
20       (in whole or in part) the requirement that broadcast  
21       stations present opposing viewpoints on controversial  
22       issues of public importance, commonly referred to as  
23       the “Fairness Doctrine”, as repealed in General  
24       Fairness Doctrine Obligations of Broadcast Licens-  
25       ees, 50 Fed. Reg. 35418 (1985).

1           (5) Requesting that action be taken by the Fed-  
2           eral Communications Commission related to the reg-  
3           ulation of Big Tech.

4           (6) Any discussion of preservation of the First  
5           Amendment to the Constitution.
