Dear Mr. Fanta,

I refer to the request you made on 25th September 2019 under the Freedom of Information Act 2014, in which you sought:

“According to information recently posted on Lobbying.ie, Ryan Meade of Google Ireland met with the Taoiseach and public officials for 2-5 times between May and August this year: <https://www.lobbying.ie/return/52698/google-ireland-limited>. I would kindly like to ask for meeting minutes, email conversations and other records relating to these meetings. In case the meetings took place at public events, feel free to point out any recordings of said events or press releases related to them.”

Following a thorough search of the records of the Department of the Taoiseach 8 records have been identified as falling within the scope of your request.

As outlined in the attached schedule, no records are being withheld, 7 records are being partially released, with redactions, 1 record is being released in full.

The decision to withhold or redact these records is based on:

- The provisions of Section 36 (1) of the 2014 Act which provides that a record, or part thereof, may be withheld where the record concerned contains commercially sensitive information.
- The provisions of Section 37 (1) of the 2014 Act which provides that a record, or part thereof, may be withheld where access to the record concerned would involve the disclosure of personal information (including personal information relating to a deceased individual).

Under the FOI Act, I am obliged to inform you that you may appeal this decision. In the event that you wish to make such an appeal, you may do so by writing to the Freedom of Information Unit, Department of the Taoiseach, Government Buildings, Upper Merrion Street, Dublin D02 R583. The fee for internal review is €30 (€10 for medical card holders and their dependants). If you make an appeal, please refer to this letter and the reference number **FOI/2019/0363** within four weeks, (20 working days) of the date of this notification.


Hi John,

Note of Taoiseach's Meeting with Susan Wojcicki, CEO Youtube, 24 July 2019, Govt Buildings

The Taoiseach was updated on the expansion of Alphabet Google in Ireland and the operation of their data centres as well as their work in running the Google Impact Challenge whereby €1m was offered in grants to not-for-profits and social entrepreneurs. Google also works with scaling-up start-up companies.

The Taoiseach was also informed on the work being done by Youtube to ensure responsibility through credible content moderation. This is achieved through the publication of guidelines to inform the work of moderators; the deployment of moderators to review flagged content; and the development of machine learning to take down content before it is reviewed by individuals.

Youtube creators, Jonathon and Anna Saconne-Joly, gave an overview of how they have built their business on youtube leading to additional employment and allowing them to reach millions of subscribers.

The Taoiseach has agreed to meet with Susan Wojcicki, CEO, YouTube on Wednesday, 24 July 2019. The following will also attend:

- Cathal Goulding, Director, Trust and Safety, Google Ireland;
- Marco Pancini, Director of Public Policy EMEA, YouTube;
- Ryan Meade, Government Affairs and Public Policy, Google Ireland; and
- Jonathon and Anna Saconne-Jolys, Irish YouTube creators.

It has been signalled that YouTube will give an update on Google and YouTube’s operations in Ireland; the YouTube creators’ ecosystem; and how YouTube is fulfilling its responsibilities as an open platform. Other issues that might arise include the EU Copyright Directive as well as the Audiovisual Media Services Directive (AVMS) and the spread of harmful content and disinformation.

Company in Ireland

YouTube was acquired by Google in 2006. Google established an EMEA HQ Operations Centre in Dublin in 2003 and it is now the largest Google office outside of the USA. Google employs over 8000 in Ireland covering a wide range of functions. The Taoiseach opened Google’s newest office on the Grand Canal in February 2018. The company has invested €350 million into two data centres in West Dublin and in June 2018 purchased the Boland’s Quay site at a cost of c. €300 million.

Copyright Directive

The Directive on Copyright in the Digital Single Market was published on 17 May 2019. It seeks to assist creators and right holders in negotiating and being remunerated for the online use of their content by certain user-uploaded content platforms. All Member States now have until 7 June 2021 to transpose the Directive in to national legislation.

Under Article 17 of the Directive, platform companies will need to obtain an authorisation from the right holders concerned if communicating their work. Where there are no licensing agreements in place, companies will have to make best efforts to obtain an authorisation. Smaller companies will be subject to a lighter regime.

DBEI officials engaged extensively with Google/YouTube throughout the negotiations on the Directive and Ireland is satisfied with the final outcome.

Online Safety Bill/Audiovisual Media Services Directive (AVMS)

Harmful and illegal content carried by video-sharing platform services (VSPS) will be regulated in Ireland under primary legislation which will implements the recently revised AVMS Directive. Under this legislation it is also proposed to establish an Online Safety Commissioner. A public consultation on these issues was in April 2019 and the submissions received will inform the development of the legislation.

Member States must implement the AVMS Directive by 19 September 2020. The Directive’s main purpose is to set down a framework for regulating traditional television broadcasting and video-on-demand services for the EU. The revised Directive now includes VSPS as a category of service. While there is some ambiguity over the definition of a VSPS, it is clear that YouTube are within the scope of the Directive.

Under the Directive a VSPS is required to put in place procedures to protect minors from content which may impair their physical, mental or moral development; and all users from hate-speech, illegal or terrorist content.

Earlier this month YouTube permanently removed the account of Irish YouTuber [REDACTED] [REDACTED] for violations of its policies aimed at protecting against hate-speech.

Terrorist Content Online

The proposed EU Regulation on this matter will require that member states establish a body to identify and refer terrorist content to hosting service providers (HSPs). The body would also issue removal orders to HSPs which would have a legally-binding 1 hr deadline. The body would receive notifications from other MS regarding removal or referral orders issued to HSPs in Ireland and issue penalties for failure to comply with these orders.

Disinformation

The European Council approved a Joint Action Plan on Disinformation in December 2018, which aims to improve the detection of disinformation, to strengthen joint responses, and to increase societal resilience. The EU Rapid Alert System (RAS) was established in March 2019 and allows for Member States to share information on disinformation activities and best practice.

Ireland has been proactive in countering disinformation, including through the establishment of an Interdepartmental Group on Security of the Electoral Process and Disinformation, chaired by the Department of the Taoiseach. The group is currently considering next steps, following a public consultation and Open Policy Forum on Regulation of Transparency of online Political Advertising.

New EU Commission

In her political guidelines for the next European Commission, President Ursula von der Leyen outlined her intention to bring forward a new Digital Services Act to upgrade EU liability and safety rules for digital platforms, services and products, and complete the Digital Single Market.

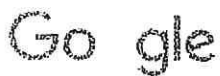

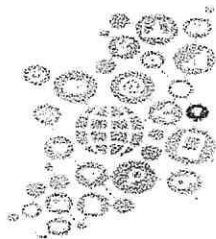

In August 2015, Google announced a significant reorganisation: Google was to become a wholly owned subsidiary of a new parent company, **Alphabet Inc** – with other Google projects/teams - which were not part of the core product – to be spun out into separate Alphabet companies, referred to as "Other Bets". The Alphabet companies include: **Google** (traditional search products, YouTube, Google Cloud, AdSense, etc.); **X** (experimental projects); **Waymo** (autonomous cars); **Verily** (healthcare); **Access** (energy and internet access); **Calico** (life sciences); **GV** (venture capital) and others. For Alphabet "Big Data" is a key driver of future growth.

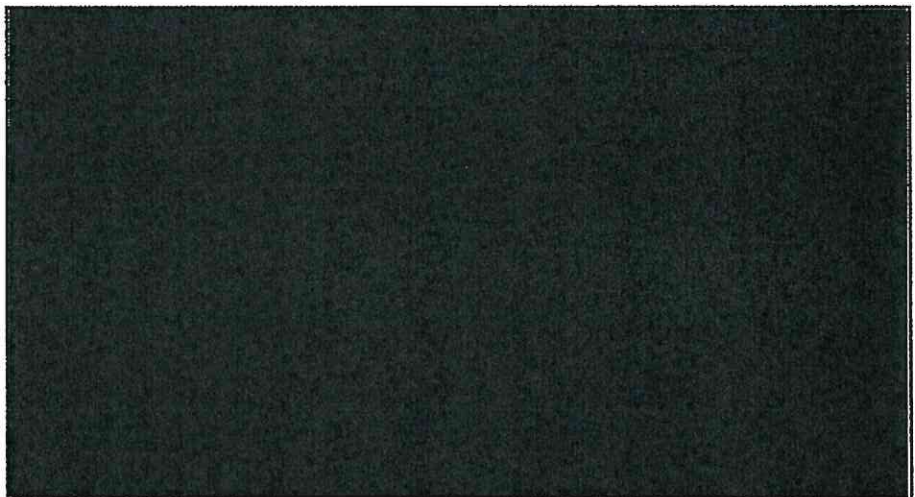
Company in Ireland

Google celebrated its 15th birthday in Ireland in 2018. In 2003, the company established an EMEA HQ Operations Centre in Dublin which is now the largest Google office outside the USA. **Google employs over 8,000 people in Ireland (4,000 direct/4,000 contractors) and the Dublin team spans 70 nationalities (75 languages spoken).** Google Dublin covers a **wide range of functions** including Sales, Advertising & Publishers Support, Engineering, and EMEA Administration (Finance, HR, Facilities, etc.).

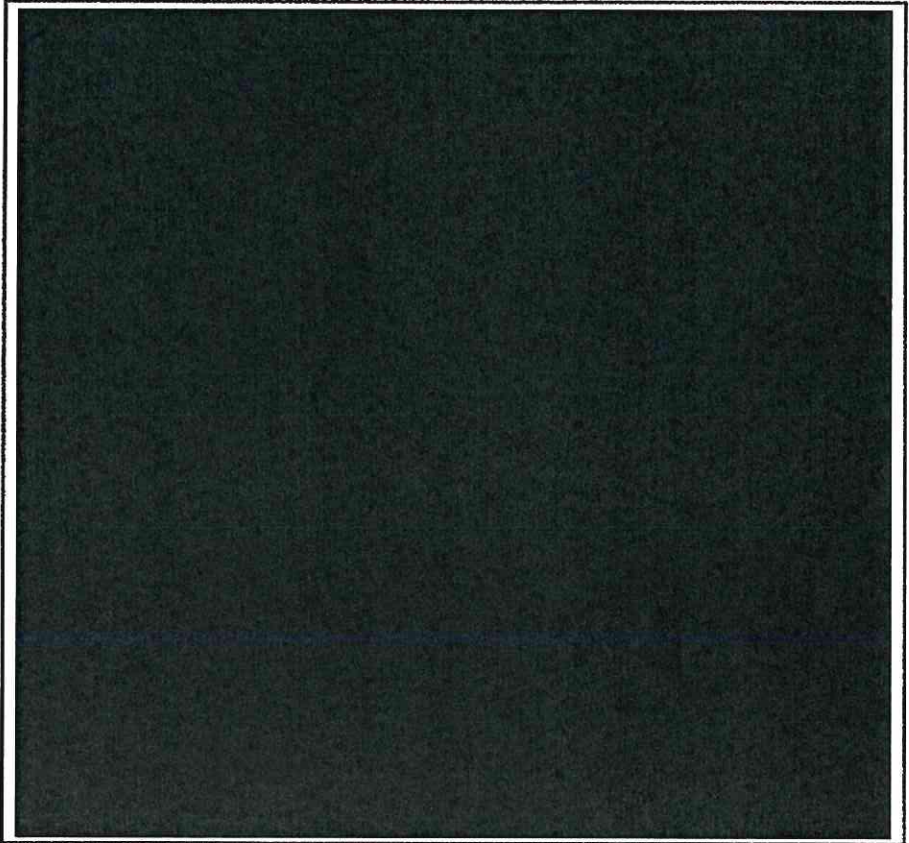
Today, Google Ireland is driving growth across the EMEA region – helping businesses make the most of the web in over 100 markets. The company employs 500+ engineers, mostly in Infrastructure and Site Reliability Engineering (SRE) i.e. these teams manage the back end systems and data centres - keeping the lights on for millions of people who use Google services across the globe. These teams are core to keeping Google services and applications such as Gmail, Google Maps and You Tube up and running 24/7. The company has invested over €350 million into two data centres in West Dublin. In February 2018, An Taoiseach Leo Varadkar officially opened Google's newest office in Dublin, which is now home to Google's growing Enterprise and Cloud teams. In June 2018 Google purchased the Boland's Quay site in Dublin at a cost of c. €300 million.

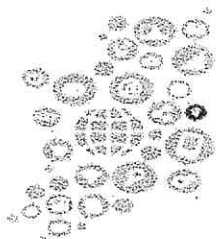

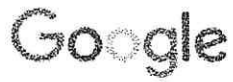
